BALLOT MEASURES

- 1. **YES** Veterans and Affordable Housing Bond Act of 2018. Legislative referendum
- 2. YES No Place Like Home Act of 2018; Mental Health Services Act funds. Legislative referendum
- 3. **YES** Bonds for projects for water supply and quality, watershed, fish, wildlife, water conveyance, and groundwater sustainability and storage. Initiative statute
- 4. YES Bonds funding construction at children's healthcare hospitals. Initiative statute
- 5. **NO** changes requirements for certain property owners to transfer their property tax base to replacement property (makes it easier to do so). Initiative constitutional amendment and statute
- 6. NO Repeals recent road repair and transportation funding by repealing the "gas tax" revenues dedicated for such; requires any new gas taxes and vehicle fees be approved by the voters. Initiative constitutional amendment
- 7. **YES** Lets Legislature study and enact year-round daylight saving time. Legislative referendum
- 8. **YES** Authorizes state to regulate kidney dialysis clinics; limits charges for patient care. Initiative statute
- 9. On July 18, 2018, **Proposition 9 was removed from the ballot** by order of the California Supreme Court.
- 10. **YES** Expands local governments' authority to enact rent control on residential property. Initiative statute
- 11. **NO** Requires private-sector emergency ambulance employees to remain on call during work breaks; changes other conditions of employment. Initiative statute
- 12. **YES** New standards for confining certain farm animals; bans sale of certain non-complying products. Initiative statute
